The Kalkaska County Road Commission reserves the right to accept or reject any or all bids, portions of bids, to waive any irregularity or defect in a bid, or to accept that bid which, in the opinion of the Road Commission, is in the best interest of Kalkaska County.

Kalkaska County Road Commission will not accept invoices containing fuel surcharges or additional charges that have not been approved by the Kalkaska County Road Commission.
